

[CALL FOR APPLICATIONS] Application for The Grant Assistance for Grassroots Human Security (GGP) is now open (Deadline: 9 February 2024)

BRIEF INTRODUCTION

Grant Assistance for Grassroots Human Security Projects (GGP) is a form of financial assistance extended by the Japanese government to developing nations. To address diverse country needs, we support projects proposed by regionally grounded organizations such as non-governmental organizations (NGOs) and local governments. This funding typically backs a relatively small-scale construction project of 10 million yen or less.

In Namibia, the GGP was first implemented in 1997, and as of December 2023, it has funded 90 (Ninety) projects nationwide. The main focus area of GGP in Namibia has been education, and other sectors (e.g., health, agriculture, and social welfare) have also received GGP so far.

APPLICANT ELIGIBILITY

Non-profit organizations that implement community-based economic and social development projects in Namibia are encouraged to apply. Non-profit organizations here include local or international NGOs, local governments, educational institutions, and medical institutions.

The proposed project site must be located within Namibia.

In principle, individuals and for-profit organizations are NOT recognized as grant-recipient organizations. Still, consideration will be given when they provide public services, such as medical institutions, schools, or humanitarian aid.

The application deadline for 2024 is at **17:00 on 9 February 2024 in Namibia Time**. Missing these deadlines might result in disqualification.
